

## SUMMER VACATION GIVEAWAY - OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. **PROMOTION DESCRIPTION:** The SUMMER VACATION GIVEAWAY ("Sweepstakes") begins on April 20, 2017, 12:00 AM and ends August 6, 2017, 2:30 AM (the "Promotion Period"). Prizes are drawn and awarded four separate times (the "Monthly Promotion Period"). Monthly Promotion Periods are (a) April 20, 2017, 12:00 AM through May 7, 2017, 2:30 AM; (b) May 7, 2017, 7:00 PM through June 4, 2017 2:30 AM; (c) June 4, 2017, 7:00 PM through July 2, 2017 2:30 AM; (d) July 2, 2017, 7:00 PM through August 6, 2017, 2:30 AM.

The sponsor of this Sweepstakes is Dirty Harry's Pub and Package ("Sponsor"). By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of Entries and the overall administration of the Sweepstakes.
